

OFFICIAL CALL

Mass Meeting of Republican Orange County Committee of the

Republican Party of Virginia

As Chairman of the Republican Orange County Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Douglas W. Rogers, do hereby issue this call for a Mass Meeting to be held at Lake of the Woods Community Center, 110 Sweetbriar Pky., Locust Grove, Virginia 22508. Registration will begin at 9:30 AM. The meeting will start at 10:00 A.M. on Saturday March 15, 2014 for the following purposes:

1. To elect up to 59 Delegates and an equal number of Alternates to the Seventh Congressional District Republican Convention, to be held on Saturday, May 10, 2014 in the auditorium at Deep Run High School, 4801 Twin Hickory Road, Glen Allen, VA. 23059 (Henrico County) or an alternate site if necessary, beginning at 10:00 AM. Registration from 9:00 AM. and shall end at 10:30 AM. . The convention shall be called to order at 10:00 AM. The purpose of the District Convention is to elect a District Chairman
2. To elect up to 59 Delegates and an equal number of Alternates to the State Convention of the Republican Party of Virginia, to be held on June 7, 2014 at the Roanoke Civic Center, 710 Williamson Road, Roanoke, VA 24016 or its alternate site starting at 10:00 AM. The purposes of the State Convention nominating a Republican candidate for the United States Senate and for the transaction of such other business as may properly come before the convention.
3. To elect a Chairman and members of the Republican Orange County Committee and to transact other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Orange County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts. Voters may be required to produce personal identification such as a valid driver's license or voter registration card and or sign a form stating they are a registered in Orange County, Virginia.

Filing Requirements

Members in good standing of the Republican Orange County Committee must pre-file as a candidate for Chairman of the Republican Orange County Committee listed above must file a "Declaration of Candidacy" form, it must be received on or before 6:00 PM, February 25, 2014. If no more than one candidate files for election to the office to be voted upon at the mass meeting, that candidate will be declared elected.

Any person wishing to file for election as a Delegate or Alternate to either the 7th District Convention or State Convention must file a "Declaration of Candidacy" form; it must be received on or before 6:00 PM, March 12, 2014.
